What You Need to Apply for Veterans Assistance

Determining your eligibility for Aid and Assistance can be time-consuming — and complicated. Patriot Angels recommends that you gather some specific information before starting the application process:

- Veteran's service information
- Monthly income
- Monthly medical expenses
- Real estate
- Life insurance
- Long-term care policy
- Assets
